	with reference to your application on the subject cited above, I am directed to convey the approval of the appropriate authority for grant of recognition in respect of your school from <u>Class Ist</u> to <u>Class VIIIth</u> (without aid) w.e.f. <u>1995-96</u> session subject to the fulfilment of the following terms & conditions :-	
	1.	That the school shall abide by the provisions of Delhi School Education Act and Rules 1973 and the instructions issued from time to time.
	2.	That the school shall appoint full time qualified and eligible staff as per the norms of the Deptt. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
	3.	That all the facilities prescribed under Rules 50 & 51 of DSER 73 shall be made available to the students. Provisions of Rules 6, 7 and 8 be strictly observed.
	4.	That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student may be added and facilities of reading room may also be provided immediately and more books worth Rs. 5000/- be purchased by the start of the next session and the list of books are furnished to the Education officer for verification.
	5. ₹	Adequate sports material shall be purchased and made available to the students immediately.
	5.	That the school shall equip the Science Lab. as per the norms of the department and suitable facilities for practical work shall be provided to the students. More material worth Rs. 5000/- shall be purchased during the current session and a list be furnished to the Education Officer for verification.
