FIRE SAFETY CERTIFICATE

Certified that the Ganga Happy Secondary School located at E - 301, Jagjeet Nagar, New Usmanpur, Delhi - 110053, comprised of ground plus three upper floors owned/occupied by Ganga Happy Secondary School was issued FSC vide letter No. F6/DFS/MS/School/2019/NDZ/2054 dated 25/10/2019. Conditions for the validity of Fire Safety Certificate

- The owner /occupier shall apply for renewal of this fire safety certificate to the Director in form J' [sub rule (1) of rule 37] along with a copy of this certificate, six months prior to its expiry
- 2. All the means of escape shall be kept free of all the type of obstruction all the time.
- 3. All the employees shall be acquainted with the use and maintenance of all fire equipment's and method of smooth and speedy safe evacuation of occupants in case of emergency.
- 4. All the firefighting equipment's shall be maintained in perfect working condition all the time and any lapse rendering non-functional of fire safety measures, management shall be responsible.
- 5. The clarification with regards electrical installation, ventilation, structure stability set back areas, occupancy and constructional deviation in building etc. may be got verified from the authorities concerned.
- 6. This Fire Safety Certificate cannot be treated in any case for regularizations of unauthorized construction unauthorized use of land if any.
- 7. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rule 2010. The form is available on <u>www.dfs.delhigovt.nic.in</u>.
